

# About mica

Mica is a pearlescent mineral used in a wide range of industrial sectors benefiting from its diverse properties:


- Reflective optical properties leveraged in cosmetics, paints and coatings
- Natural electric and thermal insulation used in electronics
- Functional filler in construction and plastics
- Lubricant in oil & gas industry



The mica challenge

Mica mining communities struggle with isolation, insecurity, illiteracy and extreme poverty. The lack of clarity of legal frameworks governing the operations of mica mines and processors create an unstable environment for the sector. These underlying conditions have led to significant social and economic problems, including:

- The use of child labor
- Poor working conditions
- Lack of access to education and healthcare
- Dependence on mica mining as a source of income
- Limited access to government social services

# RMI's approach

RMI was created in 2017 by companies in the global mica supply chain and civil society organizations that shared a commitment to eliminate unacceptable working conditions and eradicate child labor in the "mica belt" that straddles Bihar and Jharkhand. From the outset, RMI members understood that a sustainable solution would require a strategy that simultaneously addressed the interrelated underlying factors that contribute to the poor working conditions and the use of child labor in the region. That strategy evolved into RMI's three integrated program pillars that would utilize the experience and skills of multiple stakeholders to collaborate, amplify their expertise and produce results that would transform lives and livelihoods.
